Mounting

Mount the enclosure on the wall. When mounting on the wall, mount the enclosure with the word TOP at the top, and mount the device with the MGC nameplate at the top.

Removing the Device from the Mounting Plate

To remove the device from the mounting plate, remove the nameplate and the securing screw, then insert a flathead screwdriver into the slot between the device and the mounting plate, and rotate the screwdriver.
